REQUEST FOR PROPOSAL

FOR THE EXPLOITATION OF AVAILABLE LAND AND PORT FACILITIES IN
THE DR. JULES SEDNEY PORT OF PARAMARIBO, SURINAME

1. Objective

The objective of this Request for Proposal is to assess market interest in port-related services and projects through Public Private Partnerships, encompassing areas such as port or terminal management, shore base management, warehousing, tank farms, cargo storage, logistics, value-added services, and any other business associated with ports.

The Suriname Port Management Company cordially invites interested companies to specify the activities they intend to undertake at a designated facility, elucidating their cargo-generating potential and highlighting how these endeavors will contribute to the port's and Suriname's economic development.

2. Available land and port facilities

- Four land parcels ranging from 0,8 to 5,1 hectares.
- A port facility with a service area of 0,8 hectares and a quay of 97,5 meters.

3. Target parties

The intended recipients of this communication include port or terminal operators, shore base operators, logistics companies, international oil companies, both upstream and downstream entities, and other service providers associated with ports. Additionally, industries and manufacturers capable of contributing to the port's development are also welcomed as potential stakeholders.

4. Participation

Prospective companies are required to remit a participation fee of USD 100 to NV Havenbeheer Suriname's Hakrinbank account, with the USD account number 20.588.15.95. The payment should be made directly to the bank account of NV Havenbeheer Suriname, and the payment receipt must be forwarded via email to marketing@havenbeheer.sr. Upon receipt of the payment, NV Havenbeheer Suriname will promptly respond to the email by providing the Request for Proposal.

5. Selection

This Request for Proposal does not constitute a formal procurement process. Following the submission of proposals, a thorough evaluation will take place, and negotiations will ensue with the chosen party or parties, aiming to establish a partnership agreement. It is important to emphasize that adherence to the SPMC requirements is a prerequisite, and failure to meet these criteria will result in non-selection.
